¹ IVGID needs water infrastructure upgrades for fire prevention and these monies help to fund those projects; from Fiscal Years 2009-2022 the Tahoe Partnership has received \$16 million in federal funding matched with local dollars based on joint advocacy effort with MGFPC and Tahoe partners.

² In 2022, MGFPC submitted a request to Congress to provide community project funds for the Effluent Export Pipeline in Fiscal Year 2023. Congress passed legislation allocating \$1.6 million to IVGID for the Effluent Export Pipeline through the Environmental Protection Agency Clean Water SRF program; funds anticipated first half of 2023.

³ In 2022, MGFPC worked with Congress to pass legislation to increase the authorized spending level by \$365 million for the U.S. Army Corps' Section 595 Western Rural Water program. This program funds wastewater/water infrastructure projects in Nevada. This increase will allow the program to access future appropriated dollars and available Bipartisan Infrastructure Law (BIL) funds, which will help to fund larger projects advance like the Effluent Export pipeline.

⁴ In 2022, MGFPC worked with the Tahoe Fire Partnership to urge Congress to allocate up to \$10 million for fiscal year 2023 to fund municipal infrastructure upgrades for fire prevention through the Lake Tahoe Restoration Act; this funding passed in the FY23 Omnibus bill in December.
