EXPLANATION OF IVGID RECREATION PASS AND RECREATION PUNCH CARDS

The property owner may assign the **IVGID Recreation Pass** or **Recreation Punch Cards** to anyone eligible to receive an IVGID Recreation Pass and/or Punch Card by filling out an Assignment of Recreation Privileges form (opposite side). The owner chooses the length of time for which the **IVGID Recreation Pass** are to be issued: a minimum of six months to a maximum of five (5) years. Leases and Rental Agreements for tenants receiving IVGID Recreation Pass must have a minimum 6 month term, or be month-to-month. Each individual over 18 years age whose name appears on the Assignment form must also be named on the Rental Agreement. **Recreation Punch Cards** expire each year on May 31st.

If any Owner wishes to purchase up to a total of an additional five (5) Cards which may be Additional IVGID Recreation Passes or Additional Recreation Punch Cards or a combination thereof as described in Ordinance 7. The Owner may do so by paying an additional fee as set by the Board, for each Additional IVGID Recreation Pass or Additional Recreation Punch Card so purchased. The following provisions apply with respect to Additional Cards (referred to in Ordinance 7 as “Additional IVGID Recreation Passes and Additional Recreation Punch Cards”). Please refer to Ordinance 7 in its entirety for more details.

Recreation Punch Cards expire on May 31st.

IVGID RECREATION PASS:

The **IVGID Recreation Pass can only be used by the person whose picture is on it.** It can be used for the following:

- 1) Entrance to Ski Beach, Incline Beach, Burnt Cedar Beach, and Burnt Cedar Pool. Boat Ramp access for a fee. (Applies to beach access parcels only. “No Beach” properties and any passes issued against these properties do not include beach access.)
- 2) To obtain the IVGID Pass daily rates for golf** (Championship and Mountain Courses), tennis (IVGID Tennis Center), skiing (Diamond Peak Ski Area), and the Recreation Center
- 3) To obtain the IVGID Pass rate for season passes at tennis and ski.
- 4) To obtain the IVGID Pass rate for temporary, month-to-month, and annual Recreation Center memberships
