

2014 IVGID Solid Waste Containerization Proposal: *Residential Services*

What Is the Board Considering?

The District is considering potential changes to the current system used for collecting solid waste and recycling. These changes would modernize our trash collection to standardized containers used by municipalities around the nation, thereby addressing aesthetic, public health and worker safety concerns.

The Public Hearing date for Solid Waste Containerization is scheduled for Wednesday, June 25, 2014 at 6 p.m. at the Chateau (955 Fairway Blvd).



If the Board votes NO, the community continues with Existing Residential Services:

- A) **Customer provided trash containers / recycling bags**
Trash and recycling must be kept secured inside building, then placed curbside after 5 a.m. on day of service. \$20.87/month
- B) **96 gallon non-wildlife resistant WM Rental Cart**
Cart must be secured inside a building, then placed curbside after 5 a.m. on day of service. Customer purchases recycling bags. \$24.66/month
- C) **Bear Box or Wildlife Resistant Cart Service**
Customer has installed a wildlife proof metal bear box on property or owns a wildlife-resistant locking trash cart. Customer purchases recycling bags. \$20.87/month

Flat rate structure means small volume users subsidize the costs for large volume users.

Above services include:

- ◆ *Biweekly, single stream recycling collection in customer purchased blue bags;*
- ◆ *12 cubic yards of green waste (72 bags) collected seasonally during a 12 week period;*
- ◆ *Trash allocation is seven 32 gallon cans/bags per week, max.*



If the Board votes YES,

Residential Services will include:

C) **Bear Box Service** (see photos on page 1)
 Customer has installed a wildlife proof metal bear box on property. Blue recycling cart provided by Waste Management; blue bags no longer purchased by the customer. Self-owned wildlife resistant carts do not qualify for this rate. **\$19.37/month**

D) **Wildlife Resistant Cart/Recycling Cart Service**
 Waste Management carts used for all trash and recycling. Customer selects service level from 3 sizes of wildlife-resistant locking trash carts, with a standard blue recycling cart. Waste Management provides and assumes responsibility for cart maintenance, customer is not liable for damage to carts. Carts can be stored outdoors to remove attractants from the home/building.
\$28.10/month: 64 gallon carts = default service unless another service level is selected.

“Pay As You Throw” rate structure means customers pay only for the service they need. Trash allocation based on customer selected service levels.

Above services include:

- ◆ Biweekly, single stream recycling collection;
- ◆ Seasonal green waste stickered bag program (TBD);
- ◆ One dump voucher for standard pickup truck load.

If the Board votes NO, the community continues with Existing Commercial Services:

E) Currently, trash dumpsters are metal, cantilever topped units with a hasp and lock system. The latch and lock must be manually opened and closed for each use. This system is effective against wildlife access if used properly, but the manual lock system is prone to human misuse. Errors such as overfilling the units or leaving the unit unlocked has been common. The weight of the lid has been a problem for some users.

3 sizes are available (3,4,6 yard) and service is available for 1 to 5 pickups a week.

Recycling containers range from 96 gallon carts to 3, 4 or 6 yard dumpsters.



If the Board votes YES, the community Commercial Services will include:

F) ENHANCED WILDLIFE RESISTANT DUMPSTERS

All 300+ dumpsters used within Incline Village/Crystal Bay would be upgraded to Enhanced Wildlife Resistant Dumpsters. These models are used in federal recreation areas such as U.S. National Parks, National Forest and BLM visitor services areas and campgrounds. The enhanced dumpsters will replace the current dumpsters which have been prone to human misuse. Enhanced dumpsters are much easier to use and provide significant protection against wildlife access to garbage. Users open the door, drop in the garbage and close the door. The door self latches when closed by the user.
